RE: Stream Bank Stabilization Project, Fort Monmouth

Dear Mr. Fallon:

As you know, Fort Monmouth has been implementing a stream bank stabilization project since June of this year. Most of the stabilization work involves stream banks that are also landfill banks. As such, the NJDEP Division of Solid and Hazardous Waste (DSHW) has determined that the stabilization work occurring on landfill banks requires a Major Disruption Approval from DSHW.

Therefore, Fort Monmouth should apply for a Major Disruption Approval as soon as possible. Detailed guidance on applying for a Major Disruption Approval can be found in Section 9 of the "Technical Manual for Sanitary Landfill Permits and Approvals" which can be found online at <http://www.nj.gov/dep/dshw/hwtf/permits/sanlanpa.pdf>. For easy reference, I have attached to this letter the "Checklist for a Sanitary Landfill Disruption Application" from the Technical Manual.

The DSHW contact for the Fort Monmouth landfills is Janis Hottinger, at 609-984-6043. I will lend as much assistance as I can, but Ms. Hottinger should be your point of contact for any in-depth questions about the disruption application and DSHW requirements.

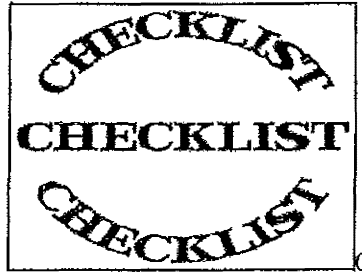

**CHECKLIST FOR A SANITARY LANDFILL DISRUPTION APPLICATION**

**Reference NJAC 7:26-2A.8(f)**

1. Solid Waste Facility Permit Application Form.
2. Topographic map depicting disrupted area and elevation drawings.
3. Written description of extent of operations, schedule of activities, purpose of disruption and other pertinent factors such as removal of the waste (see NJAC 7:26-2.11), control measures for odors, gases, leachate, surface water, dust, litter, fire, insects and rodents.
4. Health and safety plan.
5. Soil boring information.
6. List of all Departmental permits.
7. Soil erosion and sediment control plan.

The applicant will be billed the appropriate fee once the application has been received. The completed application should be mailed to the following address:
