Enclosed please find a UST Closure and Site Investigation Reports for the following Fort Monmouth-Evans Area underground storage tank sites:



The reports request "No further action". As required by the by the New Jersey Technical Regulations, all UST's sampled after January 18,1998 have the required GPS data locations included within the report. Complete electronic data deliverables are included for the first 36 UST's listed in the table above. In addition, two reports of remedial investigation activities at Buildings 9007 and 9401 and two reports of exploratory work are also included (electronic data deliverables will be delivered to you within two weeks). Lastly, electronic versions of seven previous reports already reviewed by the NJDEP have also been included for you reference.

The Army intends to transfer the property (Parcels B, C and D), which includes the above-referenced UST's, prior to April 2001. To do this, we require "No Further Action" determinations for these UST'S before January 9, 2000.
