In reply to your "Response to NJDEP comments on FOST Phase 1 Properties", the following is offered.

Parcel 28 – Based upon a review of the information submitted, it is agreed no discharge is associated with USTs 2542-29 and 2564-32 (Category 1 designation in the area of the two USTs is appropriate). Sampling remains recommended in that area designated uncategorized (UST 2544/T-7).

Parcel 35 – Although this office cannot agree with a designation of Category 1 determination without investigation in accordance with the Technical Requirement for Site Remediation, your response is acknowledged.

Parcel 36 – Based upon a review of the information submitted, it is agreed no discharge is associated with UST 1203; we concur with designation of Category 1 in the area of this UST.
